The Board has signed a lease with the Berea Masonic Center to hold our monthly Four Coordinate Body Meetings, our Reunions, and to house our robes and paraphernalia. We will hold our first Four Coordinate Body Meeting at the Berea Masonic Center on Monday, February 1, 2021. Additionally, the Board has signed a lease for our Valley Office and the Cleveland Masonic Learning Center to be housed in an office building in the city of Rocky River. This location will provide a safe and secure facility for our Office Staff, the Learning Center Staff and, most importantly, our Learning Center students and their families.

# THE VALLEY OF CLEVELAND'S FIRST HAUTS GRADES ACADEMIC

David C. Hanna, HGA, has completed the course and we had some questions for him.

What is your masonic background? (Lodge, other bodies, family?)
I have been a member of the Craft since June 2015. My home lodge



is Golden Gate #245 in Chagrin Falls, Ohio. Since then, I have become a member of: The Valley of Cleveland-SRNMJ, Al Koran Shrine, The Masonic Society, The Philalethes Society, The Ohio Lodge of Research, Quatuor Coronati Lodge #2076, Chagrin Falls Chapter #152 R.A.M., Windermere Council #113, Golden Rule Chapter #442 O.E.S., The 3-5-7 Club, The Scottish Rite Research Society-SMJ, The Grand College of Rites of the United States of America, and Oriental Commandery #12 Knights Templar.

You state that your, "experience in participation in the Hauts Grades Academy was both exciting and rewarding." Why did you participate in this program?

I decided to participate in the Hautes Grades Academy for several reasons, the principal being that I am a self-professed research hound. I love investigating historical artifacts, documents, and any other pieces that may prove valuable in learning about our world and society. This is perhaps even more so in the sphere of Freemasonry, as the Craft's own history is rich and, if investigated, available for all who are curious about it. Another key reason is the thought of being a part of a new and exciting chapter of Masonic culture. Even if the research I was conducting was based off of existing historical literature, it was still my responsibility to re-discover and present it to a new audience via my own viewpoint. In theory, such an approach would ensure that not only would the history of a particular branch of the Craft would remain intact, but would serve as a readily available source for future Freemasons to investigate further.

What was the topic of your research paper?

The topic of my Haute Grades paper was the history of the first sixty-six years of both the Northern and Southern Jurisdictions of the Scottish Rite.

How are you going to apply this to your future masonic and/or non-masonic endeavors?

I hope to apply what I have learned through the course of this project to my own participation in the Northern and, eventually, Southern Masonic Jurisdictions. Understanding their respective histories and minor differences is critical in maintaining the healthy relationship the two bodies have enjoyed and thrived with since 1867. This may also potentially serve as a positive example for all future Freemasons and the hopeful growth of the Craft throughout the world. What's more, I hope to use the knowledge I have gained in this experience towards serving as an ambassador of Freemasonry wherever I may find myself.

Is there anything else you would like to share at this time?

I am currently pursuing my Master's in Clinical Mental Health Counseling, with a career aim in treating clients suffering from depression, anxiety, and trauma. Unfortunately, such work has severely limited my availability to the Craft, however I am proud to state that I am still a happy member and am looking forward to jumping back into my Masonic duties upon graduation and career settlement.
